## GENERAL TERMS

- ENROLMENT IS PRESUMED FOR THE ENTIRETY OF 2025, I UNDERSTAND THAT FEES WILL CONTINUE TO BE CHARGED UNTIL INSPIRATION DANCE ACADEMY IS NOTIFIED IN WRITING OF WITHDRAWAL FROM CLASSES. (ONE WEEKS NOTICE FROM SCHEDULED CLASS MUST BE PROVIDED)
- AT INSPIRATION DANCE ACADEMY FEES ARE PAID BY THE FULL TERM.
- ACCOUNTS WILL BE EMAILED TO YOUR NOMINATED EMAIL ADDRESS AND WILL NEED TO BE PAID WITHIN 14 DAYS OF YOUR INVOICE DATE. FEES CAN BE PAID BY CASH, CHEQUE OR DIRECT DEPOSIT.
- IF YOUR CHILD MISSES THEIR CLASS FOR ANY REASON FEES WILL NOT BE DEDUCTED OR REIMBURSED. THEY MAY CHOOSE TO MAKE UP A CLASS AT ANOTHER TIME THROUGHOUT THE TIMETABLED CLASSES.
- FEES THAT ARE NOT FINALISED BY THE DUE DATE WILL INCUR A 5% LATE FEE. FEES THAT ARE NOT FINALISED BY THE CONCLUSION OF THE TERM WILL INCUR AN ADDITIONAL 10% LATE FEE.
- INSPIRATION DANCE ACADEMY WILL CONTINUE TO OPERATE IN ACCORDANCE WITH ANY MANDATED REQUIREMENTS BY GOVERNMENT. THIS MAY INCLUDE ONLINE LEARNING.
- INSPIRATION DANCE ACADEMY RESERVES THE RIGHT TO EXCLUDE ANY STUDENT FROM CLASSES AND PERFORMANCES WHERE INVOICES HAVE NOT BEEN PAID IN FULL AND ARE UP TO DATE.
- A NON-REFUNDABLE ENROLMENT FEE \$27.00 WILL BE INCLUDED IN YOUR FIRST INVOICE TO COVER ADMINISTRATION AND MUSIC COPYRIGHT LICENSE.
- MID YEAR DEMONSTRATION DAY PERFORMANCE FEE \$13.00 WILL BE INCLUDED IN TERM 2 INVOICE
- END OF YEAR COSTUME DEPOSITS WILL BE INVOICED IN TERM 2 WITH REMAINDER INVOICED IN TERM 3
